Chairman’s Report

Chair reported mahi across the 4 pou with most of the last month dedicated to our collective iwi-wide response to Covid-19. This response has been generated nationally as part of the Iwi Chairs Forum and in Te Hiku o Te Ika with Te Kahu O Taonui (Te Hiku Iwi Chairs). In particular this mahi included our collective [iwi influence in the area of national tangihanga restrictions](#).

Also included update on [Te Oneroa a Tohe Beach Management Plan](#), with a draft plan now in progress. Key issues remaining include integration of the four iwi-owned conservation reserves, process of RMA consenting and the strength of iwi influence in the approval process, with a need to train commissioners to provide cultural advice. 5G spectrum discussions with iwi have been on hold, with potential to establish a Māori Spectrum Commission.

CEO Report

New Te Rarawa CEO Phillip Murray reported on an exciting and extremely rewarding first four weeks. It is his honour and privilege to serve our people. The CEO reported on the response to Covid-19 and commended Te Rarawa kaimahi for their outstanding service and aroha delivered to our people. Included a detailed H&S report on Covid-19 procedures for Alert Level 2 at the Rūnanga, in service delivery and for kaimahi wellness.

Report covered TROTR Annual Plan 2020-2021 and updates on Te Rarawa Anga Mua and Te Waka Pupuri Pūtea working together more closely in alignment to achieve Te Rarawa outcomes, budgets, communications planning and improvements to Tatai iwi membership.

Included progress update on Constitution review process, ‘shovel ready’ projects for Te Rarawa marae, and the importance of giving mana motuhake to our Cultural and Environmental Pou.

Marae Items

Roma

Raised 'shovel ready' marae projects. CEO is compiling information to go to Te Kahu o Taonui who are looking to select 5 marae to fund projects. Te Rarawa will also put our own iwi-wide 'shovel ready' application forward based on the needs of all our Te Rarawa marae.

Motutī

Motutī Marae acknowledge Te Rarawa support with kai packs, vouchers and hygiene packs delivered. Whānau were especially appreciative and give special thanks to Patau Tepania for fishing and supplying fresh fish fillets. Whānau thank George and Te Rarawa Anga Mua for emergency housing solutions and the mahi with Te Kahu o Taonui. Motutī have had hui around tangihanga protocol, the marae have done really well working together to support whānau pani. Water line repairs and marae connectivity are work in progress. Submission in on Māori Whenua rating bill.

Matihetihe

Confirming that Te Rarawa is eligible to apply for 'shovel ready' funding.

Morehu

Water tank refills and cleaning well received by Pawarenga whānau. Marae in Pawarenga united and acted as one during lockdown which worked well for the Pawarenga community.

Wainui

Ahipara Takiwa prepared and delivered 500 kai packs to whānau during lockdown, including out to Tauroa. The Takiwa support closure of the road at Te Kohanga. They had a few incidents where some thought they had a right to use the road.

Taiao

Understand water levels for Kaitaia town supply have increased but Level 4 restrictions are still in place. Despite restrictions, Kaitaia water consumption has increased. Taiao marae wants to know more about what's happening. We're advised FNDC has not been sourcing water from the Sweetwater bore yet awaiting resource consent and water quality approval.

Te Rarawa

Whānau from Pukepoto would also like to thank the Rūnanga for the kai, meat and hygiene packs. The support was most appreciated, and also a good opportunity to check on kuia and kaumatua. A great opportunity to help our whānau.

Manukau

Manukau also give thanks to Te Rarawa Anga Mua for kai packs that went out to around 60 whanau. Delivering support was a good eye opener about who's in the community and Manukau found that not all whānau are registered iwi members, and they see the need to ensure whānau are registered.

Ohaki

Ōhaki gave thanks for the kai distribution, and special thanks to Patau Tepania for fresh fish delivered. They would like MSD to subsidise kaumatua water tank cleaning. Also raised marae connectivity and confirming marae has registered, and they like Ngati Kahu Facebook page.

Waiparera

Big thanks for all the mahi, the staff, marae and everyone who helped deliver support to whānau. Waiparera enquired about progress with marae insurance project.
